New generator deliveries mark progress for electric capacity

East Main Street at the Rock River Bridge was a busy place Tuesday and Wednesday when two 50,000-pound generators were installed by crane in Luverne's power plant.

The two 3-megawatt generators joined the city's existing 1960s 3-megawatt generator in the power plant.

The combined 9-megawatt continuous capacity of the three generators will ensure Luverne's backup generation can carry a major part of the city's total electrical load in the event of an outage.

Henning moves dirt in industrial park for new growth

By Lori Sorenson Four bulldozers have been working in Luverne's industrial park to move dirt in preparation for the Lineage Logistics construction this spring.

"They have moved a boatload of dirt out there already," Mayor Pat Baustian said during the March 8 City Council meeting. "Just wait for this week."

The city's role in the process is to extend Dakota Avenue 500 feet to the Lineage Logistics property line and to provide city utilities as well.

"It's not a very long stretch of road, but it goes through kind of a low area, and we'll need culverts, and there's extension of water and sewer and all those types of electrical utilities," City Administrator John Call said at a recent meeting.

During a March 10 bid letting, Henning Construction of Adrian was the low bidder at \$775,000.

"That was somewhat fortuitous for the city, because Henning is also doing the site work for Lineage Logistics," Call said. "So, they'll already be on site out there. They may want to

Feeding the grid

The new generators will also allow the city to provide more backup power for Missouri River Energy Services, which contracts with Luverne for that energy.

This service was needed in February of 2021 when Luverne's backup generator was called into action during the polar vortex.

Luverne's generator ran for 78 hours straight to support the regional power grid under pressure from the record cold snap in the south where millions of homes and on East Main Street. Another just like it was delivered Wednesday.

businesses in 10 states were without power.

Electric utility supervisor Brian Remme and his crews worked alternate shifts around the clock to monitor the generator and keep it fueled.

The backup generator is started every month to make sure it will generate power when needed, but city officials don't remember a time when the Luverne generator was used in this capacity to support a widespread power shortage.

It told its members to begin controlled outages and reached out to its member utilities for helping to generate power for the grid.

MRES currently pays the city \$75,000 per year to keep its generators in working condition for backup power in peak usage

Board approves flashing speed sign for Hills

Two solar-powered feedback signs will be placed near Hills, alerting drivers to the speed their vehicle is traveling as it enters the city limits.

The flashing signs are similar to the solar feedback signs located along County Road 4 through Magnolia.

In Hills one feedback sign will be located west of town on County Road 13 just before vehicles cross over the bridge as they enter town.

The other sign will be located on the east side of Hills along County Road 6 to alert drivers about their speed entering the city limits from the south.

Cost of the signs is \$11,163 and will be paid for by the county. According to county engineer Mark Sehr, the Hills City Council requested the signs due to concerns that drivers are entering the city at speeds exceeding the limits.

Allow flowering shrubs to bloom before pruning

Last week I encouraged you to get started cleaning up and pruning your landscape.

There are a few plants that I do not want you to prune now. This list includes all forms of lilacs, weigela, forsythia, spring-blooming spirea, mock orange, azaleas, and rhododendron. All of these shrubs have their flower buds formed in the buds of new growth, and any pruning now will remove potential flowers. For this list of shrubs, the only time to prune is immediately after they have finished blooming.

If you're not sure if your landscape includes these shrubs or what they look like, google an image so you know before you go out with your pruning shears.

I have written before about some clump-forming

perennials that get too thick and consequently lose their vigor and bloom capacity. Dwarf daylilies are an excellent example.

Often in the process of installing a landscape, plastic or fabric is used on the soil surface and covered with rock or some other mulch. A hole is cut in the fabric or plastic and the shrub or perennial is planted in that spot. The size of the hole determines how much space that plant gets to grow in.

For a single-stemmed shrub, that is not a prob-

lem. However, for a clumpforming perennial, when the plant reaches the edge of the space it is planted in, it starts to complain.

Some perennials just continue growing on top of the fabric and through the rocks, which causes its own problem. Others just start to decline because they are landlocked.

Ornamental Karl Forester Grass is a good example. As the clump grows, it spreads to the outside, leaving a dead spot in the center where it started. The base begins to look like a donut. For this perennial, you dig the entire clump, use your spade to divide it into quarters, and plant just one quarter back in the spot where you took it out.

If you do this early (before much new growth emerges), you will end up with a beautiful specimen the same growing season ... do it later, and the plant will still appreciate the renewal but will probably not recover quite as quickly.

The same procedure works well for dwarf daylilies and hosta.



Land values sharply higher into 2022

Farmland values in the Upper Midwest have reached or surpassed their highest levels in nearly a decade during the past 12 months, after several years of uncertainty from 2014 to 2020.

Average sales for high quality farm land in many portions of the Midwest and Northern Plains states are up by 20 to 40 percent in the past year.

Land values in 2021 increased at the highest year-over-year percentage rate since 2013, which followed the high farm income years from 2011 through 2013.

Many areas of the Upper Midwest experienced solid yields combined with the highest crop prices in several years to boost final 2021 farm income, which also contributed to sharply higher land values.

Land values have also been enhanced by continued relatively low longterm interest rates and very strong buyer interest in 2021 and early 2022.

There was also a limited supply of land being offered for sale during the first half of 2021; however, sales volume increased later in the year after land prices began to increase and due to concern over potential changes in tax policy by the federal government.

Southern Minnesota land values, similar to those in Iowa, were much higher in 2021 due to much higher commodity prices and average to above average crop yields in many areas.

In recent months, there have been some isolated land sales across southern Minnesota that have rivaled the highest land values per acre ever recorded. Even with the higher land values, there has continued to be a gap between the average land price for high quality and well-drained farm land compared to low quality and poorly drained land. One of the best sources of farm real estate values in Minnesota is the University of Minnesota's "Land Economics" website at landeconomics.umn.edu. This site accesses a database of various land values reported by county assessors throughout the state - adjusted annually based on actual land sales in a given county. Data released in late 2021 by the Federal Reserve districts across the U.S showed similar trends in average land values in the Upper Midwest, compared to a year earlier. The highest 12-month percentage increases at the end of 2021 were Iowa at 28 percent, Minnesota at 26 percent, and South Dakota at 23 percent. Recent data from private sources shows that

land values have continued to increase during the first three months of 2022. Some areas are showing an increase of 7 to 10 percent or more in land values since harvest was completed in the fall of 2021.

There have been numerous land sales at \$10,000 to \$14,000 per acre in Iowa and southern Minnesota, as well as other portions of the Midwest, with even higher isolated land sale values in portions of Iowa and Illinois.

Buyer interest in purchasing land has remained strong by both farm operators and investors.

Currently, most signs point toward continued increases in land values in the next 12 months.

However, there are some lingering "caution flags" that could potentially reverse this optimistic trend and revert to more downward pressure on land values. These potential challenges include:

•return to lower crop prices and lower profitability in crop and livestock farming.

•the Russian invasion of Ukraine, as well as for other global political unrest.

•several increases in long-term interest rates by the Federal Reserve Bank in the next year.

•changes in federal policies, such as estate taxes, capital gains taxes, or 1031-exchange policies.

•reduced interest to purchase farm land or a large increase in the amount of land being offered for sale. lack of confidence in the land market by farmers, investors and ag lenders. The U.S. Federal Reserve recently increased the prime interest rate by .25 percent, up to a revised prime rate of 3.50 percent. This was the first increase in the prime rate in about three years. Many economists are predicting that there could be as many as five to seven more increases in the prime interest rate in the next 12 months. The longer-term farm land real estate interest rates, which have already increased by nearly one percent in the past year, are usually based more on interest rate changes in the bond market for 10-year U.S. Treasury notes. The future trend in crop prices, the level of 2022 crop yields, and profitability in livestock production, along with the potential increases in interest rates and possible changes in government policy, will likely determine if there is further strength in land values later this year.

All current signs point to arrival of grilling season

In the span of less than two weeks we turned our clocks ahead an hour, pretended to be Irish for a day, and celebrated the first day of spring. All good signs of longer, brighter, warmer days ahead.

All of those are signs that the outdoor grilling, smoker and flat top griddle season is here.

Remember the good old days when all you had for outdoor cooking was a round charcoal grill on a flimsy aluminum-legged tripod. If you were living on the right side of the tracks, you probably had a four-legged grill, two of which had wheels.

The real key to old-fashioned grilling was the charcoal briquets and lighter fluid.

Kingsford charcoal and lighter fluid was my dad's choice. One of my most cherished memories is of my dad

teaching me the proper way to light the charcoal for grilling.

What kid wouldn't be interested in dirty charcoal, lighter fluid, matches and fire?

I suppose the way my dad started his charcoal isn't much different than the way others did, but in my eyes, it was his

way, so that became my way.

I don't currently have a charcoal grill, but if I did, this is the way I would start my charcoal: First I'd pile the charcoal in a teepee in the center of the grill. Then I'd give it a good dousing of lighter fluid and let it soak in for 5 to 10 minutes. Finally, I'd give the pile of charcoal a little squirt of fluid and then stand back and throw a lit match on the pile.

After the charcoal burns for about 15 minutes, most of it should be turning gray and the center of the charcoal teepee should be red hot.

Now it's time to spread the charcoal out, put the grill grate back on over the hot coals, let the grill grate heat up for a few minutes, and then throw those 39-cent Corn King hot dogs on the grill. We lived on the threelegged side of the tracks.







however, in the fields most seriously injured can not as yet be predicted. A fair idea of the general conditions may be gained from the information and opinions given in the following interviews:

E. N. Darling: "The frost didn't hurt my corn at all. I am going to have between fifty and sixty bushels to the acre of good corn. Wheat, barley and oats are doing fine and will be a big crop.'

Fred Kreps: "The frost didn't touch me, except a little strip in a gully. If the weather warms up pretty soon I will have one of the best corn crops I ever raised. The small grain is coming along fine and will yield above the average."

T. H. Croswell, Beaver Creek: "Take it as a whole I will have a very good crop, especially of small grain. The frost hurt my corn a little, probably ruining about onefifth of it, but the rest with favorable weather will make first class corn. I think this year's crop will compare very favorably with that of last year."

O. A. Hulett: "I don't believe the frost hurt my corn a bit. It may have delayed it a couple of weeks, but that is all. All of the small grain is fine. The recent rains have done wonders to the crops changing conditions so much that in some instances it is hardly possible to recognize the same fields. I think we'll have just as good a crop this year as last."

Ira Crawford, Beaver Creek: "It would be pretty hard to say just how much damage was done by the frost over our way. There are a lot of pieces that are probably entirely ruined. On the whole, however, I don't believe that the damage is very great. The freezing of the leaves won't hurt it except to make it a little late. If the tassel in the center of the stalk isn't frozen it will be all right and will make pretty fair corn no matter how hard the leaves were hit. All the other grain is first class and we will have a big crop if the weather continues favorable."

A. H. Turner, Magnolia: "The frost hit us pretty hard out our way. I believe that it hurt all of the grain. Almost every field of corn was hurt more or less. If everything is favorable from now on-that is if we have plenty of rain and warm weather—we will probably get about half of the usual corn crop. The recent rain came just right and has, no doubt, done a great deal of good, although it does not now show up owing to the continued cold weather. I am afraid the wheat crop will be light; possibly not over twothirds of a full crop. The barley and oat crop will be good, and fully up to the average."

J. A. Kennicott: I don't believe the corn crop is hurt half as bad as a lot of them say. Of course the frost hit a lot of it pretty hard, in some places killing it outright, but in most instances just the tops of the leaves have been touched, which with a little warm weather will come out all right and make pretty fair corn. I believe that five per cent would be a large estimate of the corn that was completely ruined by frost. Other grain will be good-about the same as last year, I should think—which means a very fair average crop. Of course, everything depends upon the weather. To make it come out right we will have to some warm weather pretty soon."

James Hagedorn: "We're going to have about a half crop this year. I don't believe that it will be to exceed that. The long dry spell cut down the yield a great deal more than most people think. No, the frost didn't hurt my corn much. I have seen some pieces that were completely ruined, but there are not very many that were. We can always raise corn here. I went down to Davenport a few weeks ago to sell my farm in the vicinity so as to buy more land in Rock county. I didn't make the sale, but I will in a short time, and when I do I will buy here. I wouldn't buy land anywhere else than in Rock county. It is the best I ever saw, and I have traveled all over the United States during the past ten years. I can raise fifty bushels of good corn to the acre without any trouble, and so can others.'

Ask a Trooper: All licensed Minnesota vehicles need front license plates, even electric cars

Question: Why do all of the Teslas I see in Minnesota lack the required front license plate? I see lots of other all-electric vehicles from other manufacturers and they all have a front plate. I know several people who have collector cars, and they all complain that they have to use a front plate, but I have yet to see a Tesla with one.

Answer: Teslas are required to have a front license plate in Minnesota. This is

a common equipment violation. Minnesota State Statute (M.S.S.) 169.79 states: "No person shall operate, drive or park a motor vehicle on any roadway unless the vehicle is registered in accordance with the laws of this state and has the license plates or permit confirming that valid registration or operating authority has been obtained."

Vehicles that are allowed to display only one license plate include motorcycles, a dealer's vehicle or vehicle in-transit, classic car, collector car or a vehicle that is of model year 1972 or earlier that is not registered as a collector vehicle and is used for general transportation purpose.

License plates must be displayed on the front and rear of the vehicle. They cannot be displayed in the front windshield or rear window. The plates must be securely mounted and displayed horizontally with the identifying numbers and letters visible. License plates issued to vehicles must also display the month of expiration in the lower left corner of each plate and the year of expiration in the lower right corner of each plate.

The plate must be unobstructed and free from grease, dust or other blurring material (dirt, mud, snow, etc.) so the lettering is visible at all times. It is unlawful to cover assigned letters and numbers or the name of the state of origin with any material, including any clear or colorless material that affects the plate's visibility or reflectivity. This also includes license plate brackets that block the state of issuance and tabs.

Why do we have two license plates? First and foremost, it is the law in Minnesota M.S.S. 169.79. From a law enforcement perspective it is safer to have two plates for several reasons:

•If an officer needs to run vehicle information they can get the plate information from the front or rear of the vehicle.

•It makes a suspect vehicle easier to identify if it is

encountered from the front or the rear.

•If a suspect vehicle is backed into a parking spot, it is more easily identified.

•Identifying a suspect in a crime (from surveillance images) is easier with front and back plates.



Practice makes perfect Hone shooting skills now to be a better shot

for hunting season later

What can you do this time of year that is outdoors- related? One of them is to start practicing whatever shooting discipline you enjoy.

I have a really hard time understanding how some of my avid pheasant hunting friends will comment when they head out on opening day that they never practiced shooting all summer.

I am a shotgun guy through and through. I expend hundreds if not thousands of rounds practicing so when that wily rooster pops up in

front of me, he ends up in my hunting vest. When it comes to rifle shooting, I am a complete amateur. I have never really had a desire to be one of those super intense guys or gals that can put five shots on a target at 500 yards or longer and all of the bullet holes touch each other in the bull's eye.

This was until about three years ago. My Pheasants Forever chapter hosts a veterans appreciation hunt every year, and I met a guy named Todd Van Langen. He is a 25-year special forces veteran who is now completely disabled. He still gets around OK but can no longer serve his county. The man is well recognized as one of the best shooters in the world.

As a thank you for inviting him to our event, he offered to put on a long-range shooting clinic as a fundraiser for our chapter. This will be the third year he has traveled from Fort Bragg, North Carolina, to Worthington to instruct such a class. The dates of this year's class are May 21 and 22.

The class is limited to 12 participants, and the cost is \$750 per shooter. A husband-wife team is counted as one shooter, and any adult child pairing is also considered one shooter for fee purposes. I watched and organized the first class and actually took the class the second year.

We had a variety of different skill level participants over those two years, ranging from dedicated shooters wanting to improve their skills to the average deer hunter wanting to gain some confidence when putting the crosshairs on a big deer, elk or other big game.

The class touts that any participant will be able to make accurate shots out past 700 yards with confidence.

I looked at myself and said that sure isn't going to be the case for me. Todd went back to North Carolina and built me a rifle from a vast array of spare parts he had accumulated over the years.

They are called skeleton guns. I have a hard time telling a \$10,000 rifle from an \$800 one. Other shooters had some specialty guns made specifically for long-range shooting, and others had \$350 guns purchased from their uncles.

The two-day class has a half day of class time instruction and 1 1/2 days of pure range shooting. I have a range set up on one of my wildlife properties that allows for shots out to 880 yards.

Todd once told me that long-range rifle shooting is all math. You do the calculations, make adjustments and pull the trigger. Wing shooting, on the other hand, is all instinct.

There is no ballistics table you can use to determine the lead on a pheasant winging 45 mph angling away at 45 degrees with an uphill trajectory of 20 degrees in a 30-mph wind.

We used some very sophisticated apps on my phone to dial in all of the math calculations for the velocity, weight and ballistic coefficient of the bullet along with wind speed and direction. After a basic understanding on my part, I went to the range with 11 other shooters to see what we might be able to accomplish.

Ten of the 12 participants had never shot at a target more than 300 yards away. By the end of the two days, each and every shooter including me was hitting the 880-yard target three out of every five attempts on average. Some did even much better than that.

I am now hooked deep into this very challenging pastime. The limiting factor for me is the competition for time from other outdoor activities and the cost of ammunition.

The class is limited to 12 participants, and three of the spots are already filled. Act now to become a better shooter even if your goal is small holes in paper targets or a clean kill on the buck of a lifetime. You might very well get hooked like I did.

The County Board was in receipt of the Fund Balance report which reflected year end settlement and the February bond payments. Motion by Overgaard, seconded by Thompson, to approve the Fund Balance report, declared carried on a voice vote.

The Auditor/Treasurer requested approval Resolution No. 03-22, a grant application for Help America Vote Act (HAVA); motion by Thompson, seconded by Burger to approve Resolution No. 03-22, declared carried on a voice vote.

Doug Bos, LMO Assistant Manager and Ryan Holtz, Rural Water Systems Manager, informed the County Board that an Administrative Penalty Order of \$9,650.00 was issued to Cody Penning d/b/a Penning Hauling from MN Pollution Control for violations of MN environmental requirements. The contamination occurred within the Rural Water well field and Bos and Holtz were pleased to state that due to immediate corrective action taken, the contaminants' never reach the rural water wells.

Bos and Holtz also presented information regarding a pilot program sponsored by Board of Water and Soil Resources and the Department of Health designed to protect well head areas. Parcels within Sections 12 and 13 (110 acres) located in Clinton Township, will be enrolled into a 30-year contract with restrictions on the production of the property. The state grant payments to the land owner will be based on RIM valuation formulas, along with other cash funds from Rural Water, and SWCD. At the end of the 30-year agreement, an easement will stay with the property. No action was required by the County Board.

Holtz provided a Rural Water activity update stating that the system distributed 294 million gallons in 2021. They have located a new and deeper well and are moving forward with MPCA to commission the new well. The new well project will ensure that the rural water system has a local backup plan in the event of water shortages. Holtz is currently applying for grant to assist with the well commissioning project along with the construction of a new water tower on the west side of the system.

The Administrator led a discussion regarding ARPA funding stating that the final rule from the federal government has a broader discretionary guideline on how to spend the funds. The final rules states that ARPA funds cannot be used for reserves or to service debt. Rock County received its first allocation and designated the funds to be allocated using the preliminary rules which was more restrictive. After considerable discussion, motion by Williamson, seconded by Overgaard to amend the APRA Phase I rules (adopted 09/21/2021) and follow the same rules adopted by the Federal Final rules in spending the ARPA funds, declared carried on a voice vote.

The County Board determined the need to meet with city and township officials regarding the Final Rule of ARPA funds, it was determined the County Board would host a meeting on February 22, 2022 at 6:00PM in basement of the Rock County Community Library. The County Board meeting of February 22nd will begin at 4:00PM to coincide with the city and township officials meeting.

The County Board briefly discussed the Revive 2030 event sponsored by Sioux Valley Electric; no action was taken.

The Administrator briefly discussed the process for re-districting stating that the county is the last unit of government to draft their new boundaries; more information will be presented as it becomes available.


