Rock County Commissioners field 80 CARES grant applications

Rock County officials received 80 grant applications in six days after announcing how CARES Act dollars would be distributed to businesses and non-profit organizations.

As of 4:30 p.m. Monday, 69 of the grant applications were received from businesses that could request up to \$5,000 in federal aid.

Eleven applications came from non-profit organizations who could also request up to \$5,000.

According to County Administrator Kyle Oldre, a review committee met Wednesday morning, July 15, to act on the grant applications. Recipients were notified Wednesday afternoon.

All recipients must sign a grant

agreement before funds are released on Friday.

The review committee will meet every Wednesday until all the dollars are distributed through the CARES Act (Coronavirus Aid, Relief, and Economic Security).

On July 7, county commissioners allocated \$500,000 in business grants. Eligible businesses could apply for up

to \$5,000 to offset economic losses sustained since March 1 due to the coronavirus.

Non-profit organizations in Rock County were allotted \$175,000 and could also apply for up to \$5,000 to offset any financial losses due to COVID-19.

All applications will be accepted until noon Aug. 15.

The county received \$1.18 million of the federal CARES Act dollars including \$44,396 for Rock County communities and townships with populations under 200.

Seven cities and townships fell in the "under 200 in population" category and will receive an allocation

Armory plans on track for 2022 opening

Architects release renderings for 47,902-square-foot industrial park facility

Architects admitit's taking a long time to plan for the new Minnesota National Guard Luverne Readiness Center, but the \$16.5 million project will open as scheduled in 2022.

Jay Wiederholt is architecture division manager with TKDA in St. Paul, the design and engineering firm for the new Luverne armory.

"The project has been moving along at a snail's pace," he said Monday. "But the review of plans has still been tracking forward."

Renderingsforthe 47,902-squarefoot facility are at the 60-percent completion stage, and drawings were released last week at the 12-week design development stage.

The facility features recruiting offices, classrooms and assembly hall for monthly guard assemblies. When not in use by guard members, the building, including two full-sized basketball courts, will be available for use by the public.

Once state and federal National Guard officials approve plans thus far, the project will enter a 22-week construction document preparation stage.

Bid letting will be early in 2021, according to Col. Sol Sukut of the Minnesota National Guard Construction and Management Office.

Since the group met in Luverne in September 2019, Sukut said two additional costs were identified and added to the project.

"The recent soil testings found a large amount of clay under the site," Sukut said.

The cost of soil remediation prior to stationing the foundation at the 15-acre site in Luverne's Industrial Park is estimated at \$200,000.

The second added expense involves up to \$1 million for a second 4,500-square-foot basketball court at the armory.

The K.A.H.R. Foundation has agreed to an additional \$1.2 million to cover those additional costs.

Beaver Creek residents petition to preserve historic bank

More than 40 residents in Beaver Creek have signed a petition to preserve the historic bank building that was given to the city by Minnwest Bank in January.

"This town and its history — this community was something," Andrew Blank told council members at their July 8 meeting. "We can tell the world we are somebody ... I feel this would be good for the city."

He and his brother, Aaron Blank, presented the signatures to council members at their June meeting asking that they postpone selling the 103-year-old building for 12 months while they considered historic uses and sought potential resources.

"The only way to preserve the building is to not sell it," Aaron Blank said.

The council tabled the request and put it on the agenda for the July meeting last week when passions for historic preservation met with practical considerations of maintenance and handicap accessibility.

Luverne EDA offers zero-percent loans

Another form of financial relief is available for local businesses affected by the pandemic economy.

Luverne Economic Development Authority took action Monday on federal aid through the Rural Business Enterprise Grant (RBEG) Program Revolving Loan Fund.

In 2013 the LEDA received a \$150,000 grant from the USDA to establish the RBEG Revolving Loan Fund, which at the time supported Luverne's Façade Improvement Program.

LEDA used matching grants so that improvements could be funded with a 35-percent loan (from RBEG revolving loan fund) and a 35-percent grant from the city with the rest from private equity.

LEDA director Holly Sammons said her office loaned out \$150,000 and granted \$150,000 to complete 13 façade improvements in the L-shaped downtown district.

"Now all of those loan dollars have revolved back into our loan fund and the USDA is encouraging cities and EDAs to update their policies to better serve businesses affected by COVID 19," Sammons said Monday.

With the updates, funds are available in the form of a zero-percent five-year "quick loan" to all Luverne businesses (not just downtown) for a wider list of projects.

In this case there's no matching grant, but Sammons said it may be useful for some businesses.

"This is a small fix option we can do for the interim, as the USDA has allowed us some flexibility," she said. "I've had a couple of businesses ask about a loan

At the July 7 meeting in Luverne, commissioners discussed with municipal and township representatives how CARES

dollars could be distributed.

"This is truly local government control on how the money is spent," Oldre told the group.

Oldre recommended that city and township supervisors reach out to their respective organizations to determine acceptable expenditures.

Cities and townships have until Nov. 15 to distribute the ACT funds. All unallocated funds come back to the county to be spent by Dec. 1.

After that any unspent dollars are returned to the state.

The former bank, which is on the National Registry of Historic Places, appraised at \$35,000 this spring when the council voted to sell it for approved uses only.

For example, it wouldn't be sold to someone who would use it for storage, but the council would approve selling it to someone who would open a business in it.

As it turns out, the city recently received a legitimate offer to buy the building for use as office space, and Mayor Josh Teune encouraged the council to act on the offer.

"Out of everything the bank could possibly be, is there anything better than an office building?" he said. "Does anyone have a better idea?"

He said the best possible scenario for preserving the historic nature of the building would be to sell it to a business

that can afford to maintain it.

As they debated the merits of history and practical use of taxpayer money, the group at one point considered using space in the Beaver Creek City Hall for historic displays.

The council took no action at the meeting, but agreed to work with the Blank brothers on finding an appropriate site in town for historic displays.

31, it marked the first time the building had been empty.

The city accepted the donation of the building with no immediate plans for it, except to maintain control over future entities that might buy it.

"It's a beautiful building, and we would have the final say about who and what goes in there," Mayor Teune said at the Jan. 8 meeting.

Council members have toured the building and said they're pleased about its condition and amenities.

For example, the roof was redone in 2013, the furnace dates back to the mid 1990s, the electrical wiring is current and working Internet connections are in place.

Help is on the way for non-profit businesses through CARES Act

As federal pandemic economic relief funds flow into accounts for businesses and municipalities, help is now on the way for non-profit businesses affected by the coronavirus economy.

The Rock County Board of Commissioners approved grants of up to \$5,000 to applicants that can demonstrate economic losses since March 1.

Among those applying for grants will be the Blue Mound Area Theatre board, which manages the Palace Theatre.

Palace director Shawn Kinsinger said losses have been staggering since the pandemic shuttered theaters and gatherings for entertainment.

"We were ready to put the Green Earth Players on stage that weekend just before the order came down from the governor," said Kinsinger, who is also vice president of the local theater group.

"We had everything paid for right down to costuming and everything came to a dead stop."

According to BMAT treasurer LaDonna VanAartsen, losses since March have reached \$40,000.

"We were also booked for the High School play, losing again on rent and concessions," she said.

"Other items included Bank Nite Movie concessions; Summer Cinema, Missoula Children's Theatre along with regular movies, which are usually really good for the summer because that is when the new blockbusters come out."

Kinsinger said he's hop $ing to \, recoup \, some \, of the \, costs$ by performing the play, "The Game's Afoot," at a later date. However, if the group decides to perform under 25-percent capacity orders, Kinsinger said it will be tough to bring in revenue.

"That's 112 people counting our volunteers and staff," he said. "After cast, crew, ushers, lights and concessions, that leaves only 80 to 90 available seats."

Considering the Palace capacity is over 400, the audience — and receipts — would be meager.

The Luverne High School students were also rehearsing for their spring play, which was scheduled to be performed at the Palace, since the high school auditorium is under construction.

"When you start looking at it, there are a lot of people affected," he said, adding that every canceled event adds up to lost revenue for the Palace.

"We had weekend movies, live music and a comedian scheduled," Kinsinger said. "That's zero income when it would have been in the thousands."

Meanwhile, there are still costs incurred through utility bills, insurance, taxes, maintenance and other expenses. Plus, employees are still paid, due to PPP loans.

"We are looking at September, but all is subject to change," Van Aartsen said. "We are prepared to open, we have our plan in place and have rehearsed it with a small group that used the theatre."

Through a grant from the Luverne Area Community Foundation, BMAT purchased a mister machine to sanitize the entire theatre after each

BMAT will be among dozens of other nonprofits to apply for grants through Rock County's CARES Act distribution.

Among other qualifications, the nonprofits must be locally owned with a physical presence in Rock County, current on property taxes and demonstrate a COVID-19-related loss since March 1.

Construction is expected to take 18 months and is scheduled for completion by November 2022.

The armory will house guard units of Luverne and Pipestone and represents a unique blend of state, federal and private funding sources.

The K.A.H.R. Foundation is the philanthropic organization of Jeannine Rivet and Warren G. Herreid II.

Herreid, a retired brevet colonel with the Minnesota National Guard, pledged \$5 million toward the new armory in Luverne in October 2017 in addition to state and federal dollars.

Uithoven Addition shows signs of building activity, utility connections

The Uithoven Addition on the west edge of town is looking increasingly like a housing subdivision, now that pavement, electricity and streetlights have been added to the neighborhood.

There are 15 lots along Uithoven Avenue, which intersects with Tallgrass and Meadowlark circles. The eight lots on the south end were sold to Cleveringa Construction

for twin homes at \$29,000 per lot. They need to be built on slab foundations due to the grade.

The three "premium" lots on the east side of the street closest to Dodge Street are $more\,conducive\,for\,single\text{-}family\,dwellings$ at \$45,000 to \$51,000 per lot.

The remaining four across the street in Tallgrass Circle are available for single family or twin home structures at \$35,000 per lot.

Lunch, substitute pay increase for H-BC schools for 2020-21 year

A 10-cent-per-meal increase will greet Hills-Beaver Creek School District families this fall, if in-person classes resume.

School board members approved the increase at their June 22 meeting.

The increase for 2020-21 follows a series of 10-cent increases each year since the 2015-16 school year.

The costs of a lunch meal for kindergarten through eighth-grade students will be \$2.75, ninth- through 12thgrade students \$2.90, and adults \$4. The cost of a carton of milk remains at 40 cents.

Board members also increased substitute staff pay schedules.

Full-day substitute teach-

ers will receive \$130 per day, up \$10 from the 2019-20 school year.

"We were a little light in that area," said Superintendent Todd Holthaus. "We should be competitive now."

Half-day substitute teacher pay is \$70 per day.

Substitute paraprofes-

sionals will receive \$13 per hour, up from \$11.50 the previous school year.

Substitute office help will be paid \$12 per hour, up \$1 per hour from the 2019-20 school year.

Substitute food service employees will now receive \$15, up from last year's \$14.


Also receiving a \$1 per hour raise is the driver education instructor to \$28 per hour.

Student participation fees and activity passes to schoolsponsored activities remain unchanged.









Don't answer Medicare insurance phone calls

Instead call Senior Linkage for unbiased help

Turning 65 comes with many emotions for me. I am excited to begin thinking about the next phase of my life. Is retirement a reality for me? Or am I going to continue to do the job I love with the Senior LinkAge Line and the Minnesota River Area Agency on Aging?

I will turn 65 at the end of October. Over the last month I have been inundated with phone calls from people trying to sell me a Medicare insurance plan. The calls usually come across as "Potential Spam," and I typically don't answer, but yesterday I decided to see what they had to say.

The caller on the other end of the line told me they were with Medicare (not true!). I questioned her further, and she said, "Medicare Benefits." Then she said she wanted to make me aware of what options Medicare had for me. Since my job with the Senior $Link Age \, Line \, is \, to \, know \, Medicare$ inside and out and provide free, unbiased information, I was skeptical.

I proceeded to ask, "Are you selling insurance?" And she said, "No, we advocate for you, so you can get the coverage you need when you turn 65." She then told me she wanted to transfer me to someone who would be able to talk to me about plans available in my area.

I asked again whether she was trying to sell me something and was told no. I agreed to the transfer, and then someone else came on the line. She gave me her name and proceeded to tell me she was a licensed insurance agent in 38 states. Not selling anything, huh?

The agent tried to make small talk. She asked my zip code and my date of birth. I told her she must know my date of birth since

she was calling because she knew I was turning 65 (silence on the other end of the phone). She never asked me if I was planning to retire or keep working. She proceeded to attempt to sell me a specific type of plan (without reviewing all the other options).

When I asked about what other options are available, she skipped right over my question and proceeded to go back to selling me the same type of plan. She told me about two companies that sold this type of plan in Minnesota but skipped by all the others.

She told me she was unbiased and wanted what was best for me. She never asked me questions about my health, my lifestyle, or what I could afford to pay in premium. These are all things that should be considered when choosing a Medicare plan.

When talking about my options under Medicare Part D, she never asked about the medicationsI take or the pharmacy I use. Without this information, you have no way of knowing your best Medicare Part D plan.

You are probably wondering why I am telling you all this. Well, quite simply, if you are getting ready to turn age 65 and live in Minnesota, you should hang up on these types of calls, or don't answer in the first place. 

•What are the human and environmental impacts of the project, and how can these impacts be address in the site permit?

•If the site permit is granted, what additional conditions or requirements should be included in a site permit for the facility?

•Are there other projectrelated issues or concerns?

Instructions to connect with the hearing via telephone and/or Internet are also included in the public notice.

A public information and environmental scoping meeting was conducted in Luverne in January, results of which recommended no major changes to the project.

Selling of longtime John Deere toy collection means keeping everything together

Kenny Scheidt's collection of John Deere collectibles began with a couple of familiar tractor models and grew to include more than 200 pieces three decades later.

Earlier this year he decided to sell the collection and ideally wants to pass on the entire 200-plus pieces to just one buyer. He placed an ad on social media with the asking price of \$22,000.

Scheidt's collection fills several display cases, and wallmounted shelves fill the front bedroom in the Scheidts' home

This spring Scheidt decided he would liquidate his collection.

"I think it's time," he said. "When the room was full, I kind of

quit buying them." Scheidt admitted he doesn't recall why the collection began and eventually grew to hundreds of pieces. He recalled the collection started small in 1988.

"I bought some (toy tractor replicas) that I drove, then I started to go to (toy) shows," he said.

The replicas date back to the late 1960s when Scheidt, at age 15, worked at farms around Adrian.

The first farm experience taught him how to drive the red-and-white International Harvester tractors. The second farm owner favored the greenand-yellow John Deere equipment, and Scheidt developed the same

At the toy shows he joined liked-minded collectors as a member of the Two-Cylinder Club that allowed him to purchase limited edition collectibles of John Deere

REMEMBER WHEN

10 years ago (2010)

•Congregation members of the American Reformed Church in Luverne broke ground Sunday morning on a major expansion that will begin this

This is a significant day in the life of the American Reformed Church in Luverne," said the Rev. Dave Sikkema during the ground breaking ceremony outside the church.

"It has been said before and will be said again, 'This is a faith-stretching project.' It is a work of God through God's people.'

The project, after more than 10 years of research and fundraising, saw an 86-percent approval during a congregational vote on June 25.

25 years ago (1995)

•In an overwhelming vote of approval, members of the Magnolia and Luverne co-op elevators decided to proceed with the planned merger of the two co-ops.

About 90 percent of the Luverne members voted yes, and more than 85 percent of the Magnolia members voted yes. Only a two-thirds majority vote was needed to pass the merger.

The boards of directors at the two co-ops proposed merging businesses for a number of reasons, including better service to customers, volume buying and merchandising, and savings passed on to customers through more competitive prices and elimination of duplicate services at the two locations.

50 years ago (1970)

•Rain, ranging in amounts of from 1 ½ inches to 3.34 inches fell over most of Rock County early Monday morning, during the day, and early evening, bringing welcome relief to drying soil conditions.

Temperatures in the 90s, fanned by southerly winds, had begun to sear lawns, crops and pastures

The rains were the first significant amounts since June 16 when 1.32 inches were recorded here. Since then, about .75 inches had fallen, with a quarter-inch being the most recorded in any one day.

Luverne had the greatest amount this week, with 3.34 on Monday and an additional .04 on Tuesday. Starting with a shower that brought sharp

lightning and thunder about 4:30 a.m. Monday, rain continued throughout the day with about an inch falling in about an hour's time, starting about 6 p.m.

Lightning during the Monday morning thundershower caused damage at the Old Bouer elevator on East Main street, and brought out the Luverne fire department. The elevator is now owned by H.A. Paulson.

75 years ago (1945)

·Holders of Rock County Fair association grandstand notes were notified this week that the fair board will make final payment on July 25.

On that date, holders of notes may bring them to Gordon Elden, fair treasurer, at the Rock County Bank, and they will receive the unpaid balance plus interest up to date.

According to L.D. Long, fair association president, the balance remaining unpaid amounts to about \$500. The fair association originally borrowed \$4,300 to build the grandstand, and has since been paying on the principal from year to year, and interest at the rate of four per cent, out of the earnings of the stand. Since its destruction by the windstorm, the as-

sociation collected on insurance policy.

100 years ago (1920)

•Condemnation pro-ceedings started some time ago by the board of county commissioners in order to secure an acre and a quarter of land on John Jones' farm, southeast of town, for gravel pit purposes, reached a successful culmination Wednesday, when Mr. Jones and the commissioners accepted a board of appraisers' valuation on the land.

The gravel deposit in question is located on land across the road on the north from the former Jaycox homestead, and adjoins the exhausted county gravel pit. The gravel was needed for continuing the state road work, and as the commissioners and Mr. Jones could not agree on the purchase price, Judge L. S. Nelson last month appointed Frank Ferguson, Herman Fitzer and C. S. Brewer as appraisers in condemnation proceedings.

Mr. Jones felt that the gravel deposit was worth \$4,000, and the commissioners offered \$750 for it, but the board of appraisers decided that \$1,600 would be a fair price, and it was at this figure that the land was bought this week.

1872: Immanuel Norwegian church precedes formation of city of Hills

The following appeared in The Rose History in 1911.

Rock County Village of Hills continued from 7-09-20 edition of the Star Herald.

The Churches — Hills has three active church organizations, the Immanuel Norwegian Evangelical Union (Synod), the United Norwegian Lutheran and the Trinity Norwegian Lutheran Free. For many years the Presbyterian society also maintained an organization, and the church building of that society still stands.

The Immanuel Norwegian Evangelical Union church of Hills antedates the town by several years. The original organization is the oldest of the Norwegian Lutheran churches in Rock county, having been organized at the home of Ole P. Steen, in Clinton township, on July 10, 1872.14 Rev. ElofOlson was the first pastor of the congregation and assisted in the organization. He was succeeded by O. Sando (1873-1878), C. A. Naeseth (1878-1882), A. Thurmo (1882-1894), and J. H. Lunde (1894-1911), who also served all the other synod churches in the county. The church was incorporated October 11, 1881. Services were held at the homes of the members until 1886.

During the summer of 1884 a church edifice was started on the site where was later built the town of Hills. When it was nearing completion it was struck by the terrible cyclone of July 21, 1884, and entirely destroyed, causing a loss of \$1800. One of the carpenters at work on the building was killed and another seriously injured. At a meeting on July 26, 1885, it was decided to erect another church edifice on the same site. The new building was completed late in December, 1885, at a cost of \$2,600. An additionwas made in 1900, making the total value of the building about \$4000. A parsonage was completed in November, 1902, at a cost of \$3500. The Immanuel church of Hills is one of the strongest, as well as oldest, in Rock county. The congregation

of this church and the one at Beaver Creek numbers at the present time about 525.

The United Norwegian Lutheran church of Hills is also one of the pioneer religious societies of Rock county. It was organized as a Norwegian Lutheran church in July, 1878, under the direction of Rev. H. Z. Hvid, and on May 5, 1879, the congregation allied itself with the United Norwegian Lutheran society. The first officers of the society were Ole Sandbo, secretary; Paul O. Sandbo, C. C. Moe and Joseph Jacobson, trustees; John Nelson, treasurer; A. Gunderson and Erick Evenson, elders; Ole. O. Blegen, deacon.

The first regular pastor of the church was Rev. J. C. Jacobson, who accepted the call on September 24, 1878.15 He was succeeded October 25, 1880, by Rev. H. Wang, who served until 1890. Rev. Theodore Fossum took the pastorate at that time and served fourteen years. He was succeeded $by \, Rev. \, C. \, S. \, Salveson, who \, served \, six years.$ The present pastor, Rev. H. O. Bjorlie, took charge of the church in 1910. One of the early day buildings of Hills was the brick

church of this denomination, erected in 1891 at a cost of \$3000 and dedicated in the fall of 1892.

The Trinity Norwegian Lutheran Free church of Hills is a comparatively new organization, but one of considerable strength. The Lutheran Free faction withdrew from the United church in 1903, and Rev. K. J. Wang accepted the call as pastor. In October of the same year it was decided to erect a church edifice. C. C. Moe, Chris Sandbo and Charles Nelson were appointed a committee to solicit funds and John Nelson, L.O. Kolsrud, C. F. Skovgaard, Thomas Johnson and Olaf Skyberg were named the building committee. A church costing \$6000 was erected and dedicated September 25, 1904.

The only English-speaking church that ever maintained an organization in Hills was the Presbyterian, which was organized in the nineties. Under the pastorate of Rev. W. F. Finch, a church building costing \$2000 was put up in 1897, and it was dedicated June 5, 1898, by Rev. R. N. Adams, D. D. For several years the organization was quite prosperous, but for the last

five years of its existence was poorly supported. In 1908 it had not a resident member, but services were held until the next year, when service was discontinued.

diving accidents and other types of water rescue anticipated to be needed locally.

The Luverne Fire Department recently chased a new rescue boat, and firefighters and first responders practiced how tohandlevictimsindifferent scenarios on the water.

According to Fire Chief David Van Batavia, the July 7 training was a useful experience.

"It was perfect," he said. "It was the first time the ambulance had been down there and the second time we've had the boat there."

The Luverne Fire Department acquired the 14 $footinflatable\,water craft for$ \$10,000 about six months ago, and Van Batavia said last week's practice was time well-spent.

"We just wanted to see what it would be like to pull someone over the side of the boat, and what we would do with a backboard to help load a patient into the boat," Van Batavia said.

'That's why we went out a few different times."

With fireman Chad Buss playing the role of the "victim," crews practiced responding to a kayaker complaining of chest pain, a kayaker unresponsive, a c-spine injury in the water and other scenarios.

The rescue boat has a 25-hp motor that can be removed to use the 300-pound (weight without the motor) watercraft for ice rescues or for flood victims.

Van Batavia said his department is not equipped for swift water rescues, which would involve specially trained Sioux Falls personnel.

Sanford Luverne coordinated the exercise through Harlan Vande Kieft, manager of Sanford Luverne's Emergency Medical Ser-

"One thing we've decided is important is working together as a team and staying current with each other's resources," Vande Kieft said.





tractors. He later added other equipment such as planters and tillage equipment and other items like semitractortrailers, coin banks, racecars and antique trucks with the John Deere logo.

Toys became more sophisticated in the 1970s and

"When the tractors first came out, they were just kids' toys," he said.

The mass-produced, inexpensive early toys of the 1950s lacked the details that Scheidt sought for his collection. As the popularity of toy collecting grew when Scheidt was a young adult, so did the details included in the models.

The toy shows' popularity meant a demand for detail-oriented toy replicas. Scheidt special-ordered

several models from vendors he met at the shows. The vendors would take a mass-produced toy and add rubber tires, levers, hydrolytic hoses and other minute details of its life-sized model.

Scheidt plans to keep these one-of-a-kind models that cost hundreds of dollars to complete, but the rest of the collection is for sale.

Among other collections

are steel-wheeled tractors, early 1980s models or New Generation selections.

Scheidt has steered clear of purchasing toys manufactured in the last decade.

"The new ones are not as detailed," he said.

It was the details that were discussed at length at the toy shows and at toy auctions throughout the U.S. But the traveling and collecting

Things are trending in the right direction, but we must continue to Stay Safe Minnesota.

1. Restaurants

- Indoor dining while maintaining social distancing
- · reservations required
- May seat no more than 50 percent occupancy

2. Social gatherings

- Indoor social gatherings can take place with 10 people or less
- · Outdoor social gatherings can take place with 25 people or less

3. Gyms, personal fitness, yoga studios, & martial arts

• May open at 25 percent capacity

4. Entertainment venues

- · Indoor entertainment venues such as theaters and concert halls, can open at 25 percent capacity.
- Recreational indoor entertainment venues, such as bowling alleys, arcades, and museums may open at 25 percent capacity.
- Outdoor entertainment venues, such as sporting events, concerts, and theaters may open at 25 percent capacity.

5. Personal services

• Personal services, such as salons, tattoo parlors, and barbershops, may increase occupancy rates to 50 percent while requiring reservations.

6. Places of worship

• Places of worship can increase occupancy rates to 50 percent.

LUVERNE IS TAKING ACTION

EMPLOYER PREPAREDNESS PLAN REQUIREMENTS CHECKLIST

Businesses and employers providing food and beverages for outside on-site consumption (such as bars, restaurants, bakeries, grocery stores and convenience stores) must develop and implement a COVID-19 Business Preparedness Plan that addresses the following components. Businesses must ensure the Plan is evaluated, monitored, executed, and updated under the supervision of a designated Plan Administrator. Employers must ensure the Plan is posted at all of the business's workplaces in readily accessible locations that will allow for the Plan to be readily reviewed by all workers, as required.

KEY REQUIREMENTS:

- Develop and implement a COVID-19 Preparedness Plan
- Open for outdoor dining or curbside pickup/delivery only
- Ensure at least 6 feet of distance with maximum on- premises capacity to no more than 50 persons
- Limit table service to 4 persons, or 6 if part of one family unit
- Require reservations; do not allow walk-in customers
- Require masks or face shields to be worn be workers
- and strongly recommend masks for all customers
- Establish regular disinfection routine and train workers
